Mannheim – November 29, 2022 – In the period from November 21, 2022, until and including November 25, 2022, a number of 33,970 preference shares (ISIN: DE000A3E5D64) and 44,041 ordinary shares (ISIN: DE000A3E5D56) were bought back within the framework of the share buyback program of FUCHS PETROLUB SE; on June 25, 2022, FUCHS PETROLUB SE disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the start of the share buyback on June 27, 2022.
