Share buyback – 68th Interim Announcement

Mannheim – October 16th, 2023 – In the period from October 9, 2023, until and including October 13, 2023, 37,450 preference shares (ISIN: DE000A3E5D64) and 41,801 ordinary shares (ISIN: DE000A3E5D56) were bought back within the framework of the share buyback program of FUCHS SE; on June 25, 2022, FUCHS SE disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the start of the share buyback on June 27, 2022.
